INFORMATION TO PROSPECTIVE SUMMER MEMBERS

Application Process:

Send applications by normal post to BSC Administration, GPO Box 311, Canberra ACT 2601. Applications are considered by the Committee as received. When an application is accepted by the Committee, your payment will be processed you will be advised by email.

All applicants are encouraged to read past Christie magazines and other information, on the Club's website.

Entitlements of Summer Adult Members

Summer Adult Members may use the Club facilities during the non-winter period and may invite guests (as Associate Members) to accompany them. The Club defines winter as the period between the June and October long weekends (for 2010 this is between Friday 11 June 2010 and Sunday 5 October 2010 inclusive.)

Summer Members may NOT book the lodges during winter as members but are welcome to use the lodges according to conditions set out for Associate Members.

Bookings conditions are documented in *Christie* the Club's magazine and on the Club's website www.brindabellaskiclub.org.au.

Summer members have no rights or privileges in relation to access to Full Membership status and, should they desire to do so, must compete with any other applicants for Full Membership when the Club advertises that applications for full membership are open.

Cost of Membership

For 2010, the Summer Adult Joining Fee is \$460 and the Annual Subscription is \$115 (a total of \$575 per adult applicant). Applicants for Junior membership incur a charge of ~50% of Adult membership – namely \$288 per junior applicant.

Babies

If your baby is born after member applications/renewals close (that is, between 1 January and 31 October 2010), on application, the Club will offer your new-born honorary junior "baby" membership for the period to 1 November 2010. Note that ALL persons in a lodge, including babies, must be booked in, and must pay the applicable accommodation charge for their stay.

Work Parties

The Club is a co-operative organisation and looks for new members who will contribute to the Club. The Club hopes new members will be active Lodge users and will actively contribute to the Club in other ways. The application form invites you to show how you propose to contribute and this information will be considered in assessing your application.

Once every five years Adult Members are expected to make a voluntary contribution to the Club, by doing a work party, assisting the committee or making a voluntary financial contribution at renewal time.

Junior Summer Members

Junior summer members are children under 18 years old for whom you are legally responsible. Junior summer members can be joined up at normal renewal time by their responsible adult who is a summer member of the Club. Junior Summer members who are 18 years old on 1 January are automatically offered adult SUMMER membership at an upgrade fee (currently \$230). Junior summer members may NOT use the lodges unless accompanied by a sponsoring adult member. Junior summer members have no booking rights and cannot automatically upgrade to FULL Junior or FULL Adult Membership.
